



INDIAN AEROSPACE SUPPLY CHAIN AND PARTNERING MISSION

BANGALORE – HYDERABAD – MUMBAI

27 NOVEMBER – 2 DECEMBER 2010

UKTI is offering a great opportunity for UK aerospace and advanced engineering companies to meet key senior executives from major India aerospace companies including: Hindustan Aeronautics Limited (HAL), Larsen & Toubro (L&T), Godrej and Boyce and other Bangalore, Hyderabad and Mumbai-based manufacturers and suppliers involved in the aerospace supply chain.

India's public and private aerospace sector is buoyant and HAL's partners and suppliers are looking for UK technology partners to help bolster the India aerospace supply chain in order to build the capacity and capability to take on offset work and expansion.

Indian companies have identified interest in the following UK capabilities:

- Materials & Manufacturing including composites, machining of exotic materials such as Inconel, stainless steel, titanium; airframe parts in fibrereinforced plastics; quartz yarn and carbon yarn; raw material compounding

- Specialist Machining and Machine Tool Capability
- Structures including metal and composites assemblies, integration of hydraulics and systems, parts and subsystems made of aluminium, titanium alloys and advanced composites, aircraft doors, tail boom, landing gears and associated tooling
- Treatments & Processes including Aluminium Metallisation, In-Mould Decoration, Investment Casting, bonding of rubber/plastic, Super plastic forming, Thermoforming

Delegates will therefore not be charged a management fee to participate in the visit. However, the British Deputy High Commission will charge A|D|S an OMIS fee to set up the group programme. This fee will be recharged equally between UK company participants and based on an assumption of 10 companies participating in the mission is anticipated to be in the region of £200 per company. In addition participants will need to cover all their flights, accommodation and personal expenses associated with this mission.
